#### POSITION OVERVIEW

This position is responsible for the provision of clinical supervision to the Mental Health(MH) and AOD teams who are a highly skilled and experienced multidisciplinary workforce including counsellors, psychologists, social workers, peer workers, care coordinators and MH nurses. This role will be key in developing and maintaining a highly skilled, thriving, professional, and engaged workforce, including reviewing the current clinical practices and professional development needs within the MH and AOD teams. The Clinical Supervisor (MH & AOD) will support the team to; develop their skills and knowledge, embed reflective practice and be evidence informed as well as contribute to innovation, quality and continuous improvement initiatives/activities. Key to this role will be driving integrative practices within the program area and across Inspiro's diverse service offerings.

#### **KEY ROLE RESPONSIBILITIES**

- Provide high quality clinical supervision according to the professional development needs and goals of each worker\*
- Develop, implement and maintain a clinical supervision structure including maintenance of accurate and timely records, logging of supervision attendance and risk escalation processes
- Informed by the MH Royal Commission findings, support staff to embed practices that are client centred, recovery oriented and align with new and emerging learning stemming from lived experience workforce investment

- Collaborate with the Lead Mental Health, Lead AOD and Lead Lived Experience to promote integration and collaboration between these streams
- Provide clinical consultation and advice to the team and promote the delivery of high-quality services ensuring that any frameworks or recommendations related to reforms or legislation (e.g., aged care, mental health, child safety, MARAM etc.) are embedded
- Develop and promote the team's professional development strategy in partnership with the MH and AOD leadership team based on best practice standards and maximise opportunities for innovation
- As required, participate in quality projects, clinical research and the development and provision of targeted training
- Provide clinical support, guidance and training to students, if required.
- Contribute to a positive and productive MH and AOD program culture and operational objectives through participation at meetings, contributing to policy development, training and project activities as required.
- Other duties as required.

\*Note that peer workers are provided with discipline specific lived experience supervision.
