## **Direct Service Provision**

- Deliver general dental services to clients of Inspiro, in line with all policies, procedures, and guidelines for practice
- Ensure services provided align with current Dental Practice Board of Victoria's Code of Practice for Dental Therapists / Hygienists / Oral Health Therapists
- Provide a "person-centred" model of care that focuses on the individual needs and circumstances of the client
- Make available and actively promote oral health promotion and information to clients within the clinical setting
- Provide professional guidance and support as appropriate for dental auxiliaries, clerical staff, and any volunteers assisting the dental program
- Ensure the appropriate referral of patients to Dental Officers

- Meet individual targets set and provide feedback to the Operations Manager Dental on issues related to clinic performance
